Učešće predstavnika ANEMa na javnoj raspravi o nacrtu Zakona o nedozvoljenoj medijskoj koncentraciji - Smatrajući da je zakon o medijskoj koncentraciji jedan od najvažnijih sistemskih zakona koji utiče na diverzitet i pluralitet medijske sfere, predstavnici ANEMa su aktivno učestvovali na javnoj debati koja je, na poziv Ministarstva kulture, održana 22. januara 2009. godine u beogradskom Sava centru. Svojim konkretnim primedbama i predlozima za poboljšanje nekih rešenja postojećeg nacrtu Zakona o nedozvoljenom objedinjavanju i javnosti vlasništva javnih glasila, koje je izneo na toj debati, ANEM nastoji da doprinese uspostavljanju optimalnog regulatornog okvira za istinsku reformu medija u Srbiji. U toku je izrada inicijative za ocenu ustavnosti Statuta grada Beograda kojim se glavnom gradu omogućava da bude osnivač medija – ANEM je, u saradnji sa medijskim udruženjima, NUNS, UNS, NDNV i Lokal press, blagovremeno, u oktobru 2008.god, podneo amandman na predlog Statuta Grada Beograda, tražeći brisanje člana 26, stav 1, tačka 5, kojim se Grad ovlašćuje da bude osnivač medija. Navedena odredba Statuta je u suprotnosti sa Zakonom o javnom informisanju i Ustavom Srbije i direktno se kosi sa principom nezavisnosti medija od političke vlasti. Kako je Skupština Grada ipak usvojila osnovni tekst Statuta Grada, koji sadrži i spornu odredbu, ANEM i ostala navedena medijska udruženja, pripremaju inicijativu Ustavnom sudu za ocenu ustavnosti i zakonitosti Statuta Grada Beograda. In this issue of ANEM News, we want to emphasize the following activities:

Public Announcement regarding the delay in appointment of members of the Republican Broadcasting Agency – In Public Announcement from February 18, 2009 ANEM protested against delay in appointment of members of the Republican Broadcasting Agency (RBA) and demanded from the authorized Committee of the Serbian Parliament to decide who the candidates are that Parliament should vote for. Effects of the economic crisis and its influence on media – ANEM President, Saša Mirković, participated in the meeting organized by Media Department of the OSCE Mission (on February

We present you a special edition of the "Serbian Law Review" dedicated to media regulation – At the initiative of ANEM and the Legal Forum, a professional publication was created which includes articles written by ten renowned experts in the media and media law. The publication offers author's opinions, a critical overview of problems in the media and proposed solutions, and represents a significant contribution to media reforms in Serbia. Participation of ANEM representatives in the public discussion about the Law on Illegal Media Ownership Concentration – Considering that the Law on Illegal Media Ownership Concentration is one of the most important laws to affect the diversity and the pluralism of the media scene, ANEM representatives have actively participated in the public discussion held on January 22, 2009 in the Belgrade Sava Centre at the invitation of the Ministry of Culture. With its specific comments and proposals for improvements of certain provisions of the current draft Law on Prohibited Consolidation and the Transparency of Ownership of Public Media Outlets made during the discussion, ANEM aims to contribute to creation of an optimal regulatory framework for realization of a true media reform in Serbia. Public appeal to regulatory institutions to solve the problem of illegal broadcasters – ANEM and the Independent Journalists' Association of Serbia have initiated a joint press conference dedicated to the problem of illegal competition from pirate stations threatening licensed broadcasters. Together with representatives of media associations, the conference was attended by representatives of the Republic Broadcasting Agency and the Republic Agency for Telecommunications. All participants of the conference condemned illegal broadcasters and agreed that it is necessary to implement more efficient measures by regulators in an effort to close all pirate radio and TV stations. Ongoing preparation of the initiative for judgement on constitutionality of the Statute of the City of Belgrade which allows City of Belgrade to establish media outlets – In cooperation with media associations, the Independent Journalists' Association of Serbia, Journalists' Association of Serbia, Independent Journalists' Association of Vojvodina and Lokal Press, ANEM submitted in October 2008 an amendment to the draft Statute of the City of Belgrade demanding elimination of the Article 26, paragraph 1, point 5 which allows the City to establish media outlets. This provision violates the principle of independence of the media from the government. Since the Assembly of the City of Belgrade has adopted the Statute of the City of Belgrade which contains the disputed provision, ANEM and the previously mentioned media associations are preparing an initiative for judgement on constitutionality and legality of the Statute of the City of Belgrade which will be submitted to the Constitutional Court. ANEM's legal affairs supported by the Swedish Helsinki Committee

ANEM stations support the campaign for inclusive education "For real" - 16 local TV stations from ANEM network responded positively to appeal of the organization "Save the Children" and joined the campaign for promotion of the right to education for all children. Member stations of ANEM contributed the campaign by free broadcasting of advertisements for
