### **1. Sugestije ANEMa za izmene i dopune Zakona o javnom informisanju**

Nastavljajući svoje aktivnosti na uspostavljanju sistema raspodele budžetskih sredstava namenjenih javnom informisanju, ANEM je uradio pisane Sugestije za izmene i dopune Zakona o javnom informisanju i dostavio ih nadležnim organima, sa predlogom pokretanja postupka navedenih izmena Zakona. ### **2. Predlozi ANEMa za regulisanje prava i obaveza imalaca dozvola i prilagođavanje dozvola u procesu digitalne tranzicije**

Iako je do datuma prelaska sa analognog na digitalno emitovanje TV programa ostalo samo 7 meseci, prava i obaveze imalaca dozvola, kao i postupak prilagođavanja dozvola u procesu digitalne tranzicije, ni do danas nisu regulisani, zbog neusklađenosti propisa koji ovu materiju regulišu. Svojim pisanim Predlozima, koje je dostavio Ministarstvu kulture, informisanja i informacionog društva, ANEM nastoji da doprinese prevazilaženju nedostataka regulative i rešavanju ovih pitanja na najpovoljniji način za emitere. Učestvujući u javnim konsultacijama o Predlogu pravilnika o tehničkim zahtevima za uređaje i programsku podršku za zakonito presretanje elektronskih komunikacija i zadržavanja podataka o elektronskim komunikacijama, ANEM je dostavio svoje pisano mišljenje Ministarstvu kulture, informisanja i informacionog društva, kojim je Ministarstvu predložio da povuče Predlog pravilnika, odnosno da pripremi novi. U postupku, koji se vodi pred Komisijom za autorsko i srodna prava povodom Predloga jedinstvene tarife OFPS-a i PI-a, ANEM je, kao reprezentativno udruženje emitera, na zahtev Komisije, dostavio svoje pisano izjašnjenje na Predlog te tarife. Od mišljenja Komisije zavisi da li će Predlog ove tarife u odnosu na emitere stupiti na snagu ili će se pregovori ponavljati. Nakon završetka javne rasprave, mr Jelena Surčulija, koordinator Radne grupe Ministarstva kulture, informisanja i informacionog društva je za potrebe ANEMa uradila analizu svih komentara učesnika javne rasprave o Nacrtu medijske strategije koji su objavljeni na sajtu Ministarstva. ## 6. Saopštenja ANEMa

Krajem jula 2011, ANEM je izdao dva saopštenja povodom ometanja rada njegovih stanica: veb sajt Radija City iz Niša bio je napadnut od strane albanskih hakera (pročitajte više u [ANEMovom saopštenju od 28.07.2011](#)), a Timočkoj TV iz Zaječara je onemogućeno da kvalitetno i redovno informiše građane o stvarima od javnog interesa ([ANEMovo saopštenje od 27.07.2011](#)). Pored toga, ANEM je 03.08.2011 izdao [saopštenje](#) u kome se pridružio zahtevu Poverenika za informacije od javnog značaja i zaštitu podataka o ličnosti za produženje roka trajanja javne rasprave o Predlogu pravilnika o tehničkim zahtevima za uređaje i programsku podršku za zakonito presretanje elektronskih komunikacija i zadržavanja podataka o elektronskim komunikacijama, smatrajući da rešenja iz predloženog Pravilnika predstavljaju pretnju za poštovanje i ostvarivanje ljudskih prava, a posebno prava na slobodu izražavanja, te da stoga zahtevaju ozbiljnu analizu i izmene.

## 7. Pravni Monitoring medijske scene

ANEM, u saradnji sa ekspertskim timom advokatske kancelarije „Živković&Samardžić“, kontinuirano sprovodi pravni monitoring medijske scene u Srbiji, baveći se analizom aktuelnih dešavanja u medijskom sektoru u oblasti slobode izražavanja, implementacije zakona i usvajanja novih zakona, rada regulatornih tela, državnih organa i kolektivnih organizacija za zaštitu autorskog i srodnih prava, procesa digitalizacije i privatizacije. ### ANEM Newsletter – No. 19

#### 1. ANEM Suggestions for amendments to the Public Information Law

Continuing its activities toward establishment of a system of allocation of the state budget funds earmarked for public information, ANEM has prepared the written Suggestions for amendments to the Public Information Law and submitted them to competent authorities, proposing to launch a procedure for introducing these amendments to the Law. Suggested amendments would change the

Law in a way as to define the public interest in the media sphere and regulate the system of state aid. You can read ANEM Suggestions [here](#).

## **2. ANEM Proposals for regulating the rights and obligations of licenses holders and adjustment of licenses in the process of digital transition**

Although it is only 7 months left before the date of switchover from analogue to digital broadcasting of TV programs, the rights and obligations of licenses holders as well as the procedure for licenses adjustment in the process of digital transition have not been regulated yet, due to inconsistency of legal acts governing this field. Through its written Proposals, submitted to the Ministry of Culture, Media and Information Society, ANEM strives to contribute to overcoming of the legislation shortcomings and to solving these issues in the most beneficial way for the broadcasters. ## **3. ANEM opinion on the Draft Rulebook on technical requirements**

Taking part in public consultations on the Draft Rulebook on technical requirements for equipment and program support for lawful interception of electronic communications and electronic communications data retention, ANEM has submitted its written opinion to the Ministry of Culture, Media and Information Society, suggesting to the Ministry to withdraw the Draft Rulebook, namely to prepare a new text of the Draft. ## **4. ANEM opinion on the Proposal of unique tariff of OFPS and PI**

In the procedure before the Commission for Copyright and Related Rights regarding the Proposal of unique tariff of OFPS and PI, ANEM as the representative association of broadcasters, has submitted its written opinion on this Proposal, acting on the request of the Commission. Depending on the opinion of the Commission, the Proposal of this tariff would be enforced for broadcasters or the negotiations would be repeated. ## **5. Analysis of comments of the public debate on Draft Media Strategy participants**

After the completion of the public debate, Jelena Surculija, MA and coordinator of the working group of the Ministry of Culture, Media and Information Society, conducted an analysis, for ANEM purposes, of all comments of the participants in the public debate on the Draft Media Strategy that were published on the Ministry's website. This analysis would also serve to the media coalition in the further procedure of adoption of the Media Strategy. The analysis is available on ANEM website, [here](#).

## **6. ANEM Public Statements**

At the end of July 2011, ANEM has released two public statements regarding disruption of work of its stations: the Radio City Nis website was attacked by Albanian hackers (read more about it in [the ANEM Statement, July 28, 2011](#)) while the Timocka TV was prevented from providing information to citizens in a high-quality and regular manner ([ANEM Statement, July 27, 2011](#)). On August 3, 2011, ANEM released the [statement](#) in which it has joined the Commissioner for Information of Public Importance and Personal Data Protection in his demand for the extension of the deadline for completion of the public debate on the Draft Rulebook on technical requirements for equipment and program support for lawful interception of electronic communications and electronic communications data retention, estimating that the solutions of the proposed Rulebook constitute a threat to respecting and exercising human rights, especially the right to freedom of expression, and hence they should undergo serious analysis and changes.

## **7. Legal Monitoring of the media scene**

ANEM, in collaboration with the expert team of the Law office "Zivkovic&Samardzic", has been continuously conducting legal monitoring of the Serbian media scene, performing the analysis of the current affairs in the media sector in the area of freedom of expression, the implementation of laws

and adoption of new laws, work of regulatory bodies, competent authorities and collective organizations for copyright and related right, the processes of digitalization and privatization. #### **8. ANEM took part in awarding the MLADGRAD 2011.**

Supporting its partners from the civil sector, ANEM took part in awarding the MLADGRAD 2011 as a “friend of the Award”. ANEM has participated in the jury for granting this award, which has been assigned by Civic Initiatives, second year in a row, to local self-governments, formal and informal organizations and individuals who contributed to improving the position of young people in local communities.
