ANEM je u protekla dva meseca sproveo niz aktivnosti, a ovde vas podsećamo na najvažnije:

1. ANEM-ove sugestije za Nacrt Zakona o elektronskim medijima

Kako je u toku izrada seta medijskih zakona, ANEM je krajem decembra 2012. dostavio Ministarstvu kulture i informisanja i Radnoj grupi za izradu medijskih zakona svoje pisane sugestije za Nacrt zakona o elektronskim medijima. Sugestije ANEM-a se odnose na principe koje bi trebalo poštovati prilikom izrade Nacrta zakona, a usmerene su na poboljšanje pojedinih rešenja koja sadrži Prednacrt tog zakona koji je javno predstavljen u junu 2012. godine. 2. ANEM-ove sugestije za Nacrt Zakona o javnim servisima

ANEM je 28.12.2012. Ministarstvu kulture i informisanja i Radnoj grupi za izradu medijskih zakona dostavio i svoje pisane sugestije za Nacrt Zakona o javnim servisima. ANEM je istakao da, po njegovom mišljenju, nije potrebno donositi poseban zakon koji reguliše javne servise, ali imajući u vidu da Medijska strategija ostavlja takvu mogućnost, ANEM je u svojim sugestijama naveo osnovne smernice za koje smatra da su u interesu medijskog sektora i da ih treba uzeti u obzir prilikom eventualne izrade Nacrta tog zakona. 3. Inicijativa ANEM-a za donošenje novog Zakona o oglašavanju

Smatrajući da Zakon o oglašavanju ima veoma važan uticaj na funkcionisanje medija, a da ima brojne nedostatke, ANEM je 12.12.2012. uputio dopis Ministarstvu spoljne i unutrašnje trgovine i telekomunikacija i Ministarstvu kulture i informisanja, kojim od ministarstava traži donošenje novog Zakona o oglašavanju i njihovu međusobnu saradnju u tom procesu. **Ovde** možete pročitati koji su ANEM-ovi razlozi za ovakav zahtev.

4. Aktivnosti ANEM-ovog pravnog monitoringa medijske scene u Srbiji

a) ANEM-ovi Monitoring Izveštaji o medijskoj sceni Srbije

U ovom periodu, na web sajtu ANEM-a, objavljeni su **Trideset osmi**, **Trideset deveti** i **Četrdeseti** Monitoring Izveštaj, u kojima možete pročitati šta je obeležilo medijsku scenu u poslednja tri meseca 2012. godine.

b) Sedma Monitoring Publikacija ANEM-a

U decembru 2012, ANEM je objavio elektronsku i štampanu verziju **Sedme Monitoring Publikacije**, koja sadrži 4 autorska teksta i prikaz dve presude Evropskog suda za ljudska prava koje se odnose na primenu člana 10. Evropske konvencije za zaštitu ljudskih prava i osnovnih sloboda. Za ovaj broj Publikacije, pisali su: Rodoljub Šabić, Poverenik za informacije od javnog značaja i zaštitu podataka o ličnosti; Dragoljub Popović, sudija Evropskog suda za ljudska prava; advokat Kruna Savović i advokat Slobodan Kremenjak. 5. Inicijativa za pokretanje postupka za izmenu Zakona o glavnom gradu

Smatrajući da je Zakon o Glavnom gradu u direktnoj suprotnosti sa važećim medijskim zakonima i Medijskom strategijom, Medijska koalicija (ANEM, NUNS, UNS, NDNV i Lokal pres) je 26.12.2012. uputila nadležnom ministarstvu Inicijativu za pokretanje postupka za izmenu ovog zakona, u delu u kojem predviđa da Grad Beograd može da osniva javna glasila. 6. Učešće u javnoj raspravi o Nacrtu izmena Zakona o lokalnoj samoupravi

ANEM je sa partnerima iz Medijske koalicije (NUNS, UNS, NDNV, Lokal pres) učestvovao u javnoj raspravi o Nacrtu zakona o izmenama i dopunama Zakona o lokalnoj samoupravi. U zajedničkim pisanim komentarima i sugestijama, koje su 14.12.2012. dostavljene nadležnom ministarstvu, Koalicija je tražila da se izvrše dodatne izmene važećeg Zakona o lokalnoj samoupravi, koje nisu bile u Nacrtu, a odnose se na odredbe koje nisu u skladu sa medijskim zakonima i Strategijom. 7. Amandmani na Predlog zakona o javnim preduzećima

Predlog zakona o javnim preduzećima, koji se početkom decembra našao pred poslanicima Narodne skupštine, sadržao je odredbu koja bi omogućila opstanak starih, odnosno, osnivanje novih javnih preduzeća u oblasti informisanja. Protiveći se ovakvom rešenju, koje je u direktnoj suprotnosti sa važećim medijskim zakonima i sa Medijskom strategijom, ANEM, NUNS, UNS, NDNV, Lokal pres, kojima se pridružila i Asocijacija medija, sproveli su u decembru 2012. niz zajedničkih aktivnosti, koje su doprinele da doneti Zakon o javnim preduzećima ne sadrži spornu odredbu. 8. Amandman na Predlog zakona o izmenama i dopunama Krivičnog zakonika

Kako bi sprečili brisanje stava 3 člana 138. Krivičnog zakonika, kojim je novinaru u slučaju pretnji u vezi s poslom koji obavlja, zbog značaja profesije garantovana veća zaštita u odnosu na lica koja ne obavljaju te poslove, ANEM je sa partnerima iz Medijske koalicije (NUNS, UNS, NDNV i Lokal pres) tokom decembra sproveo zajedničke aktivnosti. Jedna od njih je i amandman na Predlog zakona o izmenama i dopunama Krivičnog zakonika, koji je doprineo da Krivični zakonik, i nakon izmena, licima koja obavljaju poslove od javnog značaja u oblasti informisanja pruža povećanu zaštitu u slučaju ugrožavanja njihove sigurnosti. 9. Saopštenja ANEM-a

U ovom periodu ANEM je izdao više saopštenja kojima je reagovao na događaje u medijskom sektoru koji ugrožavaju funkcionisanje medijskog sistema i rad i bezbednost novinara i medija. Mnoga od njih su bila rezultat ostvarene saradnje sa partnerima iz medijskog sektora.

Zajedničkim **saopštenjem od 4.12.2012.** ANEM, NUNS, UNS, NDNV i Lokal pres, koji čine Medijsku koaliciju, usprotivili su se rešenju Predloga zakona o javnim preduzećima, kojim je predviđena mogućnost osnivanja javnih preduzeća u oblasti informisanja, ističući da je to u direktnoj suprotnosti sa Medijskom

strategijom i osnovnim načelima medijskih sloboda. Dan kasnije, Medijska koalicija je dostavila nadležnim organima konkretne amandmane na Predlog tog zakona, koje je podržala i Asocijacija medija, o čemu su sva udruženja iz medijske zajednice (Medijska koalicija i Asocijacija medija) obavestila javnost svojim zajedničkim **saopštenjem od 5.12.2012.** Medijska zajednica je **saopštenjem od 6.12.2012.** nakon održane sednice Odbora za kulturu i informisanje Narodne Skupštine, saopštila javnosti da je na toj sednici obavestena da je Vlada prihvatila njene amandmane i da će predložiti Skupštini njihovo usvajanje.

ANEM je **saopštenjem od 14.12.2012.** obavestio javnost da je nadležnim ministarstvima uputio dopis kojim traži donošenje novog Zakona o oglašavanju, zbog njegovih brojnih nedostataka, kao i saradnju dva ministarstva – Ministarstva spoljne i unutrašnje trgovine i telekomunikacija i Ministarstva kulture i informisanja, u tom procesu.

Medijska koalicija je **saopštenjem od 14.12.2012.** zajednički protestovala protiv odluke lokalne vlasti u Ljigu da pokrene proceduru osnivanja JP za informisanje i marketing „Televizija Ljig“, upozoravajući da je takva odluka u suprotnosti sa Medijskom strategijom.

Saopštenjem od 19.12.2012. Medijska koalicija je obavestila javnost da je svojim amandmanom na Predlog zakona o izmenama i dopunama Krivičnog zakonika tražila od nadležnih organa da u Zakoniku ostane odredba kojom se novinarima, zbog značaja profesije koju obavljaju, pruža povećana zaštita u slučaju ugrožavanja njihove sigurnosti.

Pružajući podršku svojoj članici, radiju Patak iz Valjeva, i urednici tog radija, Dariji Ranković, ANEM je **25.12.2012.** javno reagovao **saopštenjem** zbog uvreda i pretnji kojima su novinari bili izloženi na sednici lokalnog parlamenta.

Medijska koalicija je **27.12.2012.** objavila da je nadležnima uputila dopise kojima traži izmene Zakona o glavnom gradu i Zakona o lokalnoj samoupravi, jer su u direktnoj suprotnosti sa medijskim zakonima i Medijskom strategijom. Više u saopštenju **ovde.**

Reagujući na govor mržnje u nedeljniku „Pečat“, ANEM je **19.01.2013.** **saopštenjem** izrazio solidarnost sa kolegama iz RTV-a i NDNV-a i zatražio od nadležnih da reaguju povodom napada i suzbiju medijski i svaki javni govor koji se ne može kvalifikovati drugačije nego kao raspirivanje nacionalne mržnje među nacionalnim zajednicama u Srbiji.

10. ANEM-ov projekat „Ilustrovani rečnik korupcije“

ANEM je u decembru 2012. otpočeo implementaciju svog 18-mesečnog projekta, pod nazivom „Ilustrovani rečnik korupcije“. Opšti cilj ovog projekta je doprinos efikasnijoj prevenciji i borbi protiv korupcije, kroz uključivanje građana i medija u ceo proces. U realizaciji ovog projekta, ANEM će saradivati sa Agencijom za borbu protiv korupcije, kao najvažnijim projektnim partnerom. Detaljnije o samom projektu pogledajte **ovde.**

ANEM Newsletter No. 26

In the past two months, ANEM carried out a number of activities. In this issue of ANEM Newsletter, we bring you the most important ones:

1. ANEM recommendations for the Draft Law on Electronic Media

As the work on the set of media laws is currently underway, ANEM submitted, in late December 2012, its written recommendations for the Draft Law on Electronic Media to the Ministry of Culture and Media and the Working Group for the development of media laws. ANEM recommendations concern the principles that should be followed when writing the Draft Law and are focused on improving certain solutions contained in the pre-draft of this Law, which was publicly presented in June 2012. 2. ANEM recommendations for the Draft Law on Public Service Broadcasting

On December 28, 2012, ANEM submitted to the Ministry of Culture and Media and to the Working Group developing media laws its written recommendations for the Draft Law on Public Service Broadcasting. ANEM noted that, in its opinion, passing a separate law governing public service broadcasting was not necessary; however, given that the Media Strategy provided for such possibility, ANEM presented in its recommendations basic guidelines deemed to be in the interest of the media sector and which should be taken into account in the possible creation of the Draft of this Law. 3. ANEM initiative for adoption of a new Advertising Law

Considering that the Advertising Law has a very important impact on the functioning of media, and that the current Law has a number of shortcomings, ANEM sent a letter on December 12, 2012 to the Ministry of Foreign and Domestic Trade and Telecommunications and the Ministry of Culture and Media, requesting the adoption of a new Advertising Law and calling the ministries on mutual cooperation in this process. 4. Activities of ANEM legal monitoring of the Serbian media scene

a) ANEM Monitoring Reports on the Serbian media scene

In this period, the [Thirty-eighth](#), [Thirty-ninth](#) and [Fortieth](#) Monitoring Reports were published on ANEM website. In these Reports, you can read about what marked the media scene in the last three months of 2012.

b) The Seventh ANEM Monitoring Publication

In December 2012, ANEM released electronic and printed version of its **Seventh Monitoring Publication**, containing 4 author's texts and overview of two judgments of the European Court of Human Rights relating to the application of Article 10 of the European Convention for the Protection of Human

Rights and Fundamental Freedoms. In this issue of the Publication, the authors of the texts were Rodoljub Sabic, the Commissioner for Information of Public Importance and Personal Data Protection; Dragoljub Popovic, Judge of the European Court of Human Rights; attorney at law Krupa Savovic and attorney at law Slobodan Kremenjak. **Electronic version of the Publication** can be downloaded from ANEM website.

c) Round Table – presentation of printed edition of the Seventh Monitoring Publication

On December 14, 2012, ANEM organized in Belgrade a round table to publicly present the printed edition of its Seventh Monitoring Publication. The Publication was presented by the authors of the texts, after which a constructive discussion was carried out. Report from this round table can be found **here**.

Activities of the Legal Monitoring of Serbian Media Scene, which have been realized for three and a half years, will continue in 2013 as well. More about it soon!

5. Initiative for amending the Law on Capital City

Considering that the Law on Capital City is in direct contradiction with the current media laws and Media Strategy, on December 26, 2012, the Media Coalition, consisted of ANEM, NUNS, UNS, NDNV and Local Press, submitted to the competent ministry the initiative for launching the process for amending this Law, in the part stipulating that the City of Belgrade could establish the public media. 6. Participation in the public discussion on the Draft Amendments to the Law on Local Self-Government

ANEM, together with its partners from the Media Coalition (NUNS, UNS, NDNV, and Local Press) participated in the public discussion on the Draft Law on Amendments to the Law on Local Self-Government. In joint written comments and recommendations, forwarded to the competent ministry on December 14, 2012, the Coalition requested additional amending of the current Law on Local Self-Government, namely amendments not contained in the Draft, but related to provisions that were not in accordance with the media laws and the Media Strategy. What was requested, and why, see **here**.

7. Amendments to the Proposed Law on Public Enterprises

The Proposed Law on Public Enterprises, which was tabled to the Serbian Parliament in early December, contained a provision that would allow for the existence of old and the establishing of new public companies in the field of information. Opposing this solution, which is in direct contradiction with the current media laws and the Media Strategy, ANEM, UNS, NUNS, NDNV and Local Press, supported ultimately by the Association of Media, conducted in December 2012 a number of joint activities that had resulted in the Law on Public Enterprises not containing the contentious provision. 8. Amendment to the Proposed Law on Amendments to the Criminal Code

During December 2012, ANEM implemented a number of joint activities together with its partners from the Media Coalition (NUNS, UNS, NDNV and Local Press), in order to prevent deletion of paragraph 3 of Article 138 of the Criminal Code guaranteeing greater protection to journalists in the case of threats made in connection with their work than to persons not performing this job, due to the importance of the journalistic profession. One of the activities was the amendment to the Proposed Law on Amendments to the Criminal Code, which had contributed that the Criminal Code, even amended, provided greater protection to persons performing activities of public interest in the field of information in cases when their safety was being threatened. 9. ANEM Public Statements

In this period, ANEM issued several statements, reacting to events in the media sector that had threatened the functioning of the media system and the work and safety of journalists and media. Many of them were the result of accomplished collaboration with the partners from the media sector.

With the joint **statement on December 4, 2012**, the Media Coalition, composed of ANEM, NUNS, UNS, NDNV and Local Press, opposed to the Proposed Law on Public Enterprises, which provided for the establishment of public companies in the field of information. In the statement, the Coalition pointed out that the Proposed Law was in direct contrary to Media Strategy and the fundamental principles of media freedoms. A day later, the Media Coalition submitted concrete amendments to the Proposed Law to the authorities, which were supported by the Association of Media as well. All associations from the Media Community (Media Coalition and the Association of Media) informed the public with their joint **statement on December 5, 2012** about this activity. After the session of the Parliament's Culture and Information Committee, the Media Community informed the public with the **statement on December 6, 2012**, that it was notified at the session that the Government had accepted its amendments and would propose them to the Parliament for adoption.

With the **statement on December 14, 2012**, ANEM informed the public that it had sent a letter to the relevant ministries requesting the adoption of the new Advertising Law, because of its many shortcomings, as well as calling on cooperation of the two ministries in the process – Ministry of Foreign and Domestic Trade and Telecommunications and the Ministry of Culture and Media.

The Media Coalition jointly protested in the **statement on December 14, 2012** against the decision of local authorities in Ljig to initiate the procedure for the establishment of Public Company for Information and Marketing "Television Ljig", warning that the decision was not in line with the Media Strategy.

Media Coalition informed the public with the **statement on December 19, 2012** that it had proposed to the authorities the amendment to the Proposed Law on Amendments to the Criminal Code, which would preserve the provision providing for the greater protection of journalists in cases of threats to their safety because of the importance of the journalistic profession.

Supporting its member, radio Patak from Valjevo, and editor of this radio, Darija Rankovic, ANEM publicly protested in its **statement on December 25, 2012** over the insults and threats the journalists were subjected to during the session of the local parliament.

The Media Coalition announced on **December 27, 2012** that it had sent official letters to the competent authorities requesting the amendments to the Law on Capital City and the Law on Local Self-Government, as they were in direct contradiction with the media laws and the Media Strategy. Reacting to the hate speech in the weekly "Pecat", ANEM expressed its solidarity with colleagues in RTV and NDNV in the **statement on January 19, 2013**, urging the authorities to adequately respond to the attack and put an end to any form of public speech that could be qualified only as an encouraging hatred among ethnic communities in Serbia.

10. ANEM project "Illustrated Glossary of Corruption"

In December 2012, ANEM had started implementation of its 18-month long project, entitled "Illustrated Glossary of Corruption". The overall objective of this project is to contribute to effective prevention and fight against corruption by involvement of citizens and the media in this process. ANEM will cooperate with the Anti-Corruption Agency in the implementation of the project, as the most important project partner. More details about the project are available **here**.
