1. PRAVNI MONITORING MEDIJSKE SCENE U SRBIJI

a) ANEM-ovi Monitoring Izveštaji o medijskoj sceni Srbije

10. SAOPŠTENJA ANEM-a

U svom saopštenju od 15. jula 2013, ANEM je najoštrije protestovao povodom tekstova objavljenih u dnevnom listu "Informer" u poslednja dva broja, kojima se dodatno ugrožava, kako sigurnost Verana Matića, tako i sigurnost drugih novinara koji su trenutno pod policijskim obezbeđenjem ili će im takvo obezbeđenje u budućnosti biti određeno.

ANEM je, sa partnerima iz Medijske koalicije (NUNS, UNS, NDNV i Lokal Pres), u [zajedničkom saopštenju od 14. juna 2013](#), pozdravio odluku Ustavnog suda Republike Srbije kojom su proglašene neustavnim pojedine odredbe Zakona o elektronskim komunikacijama u pogledu pristupa zadržanim podacima, a koje su bile sporne još prilikom procesa usvajanja ovog zakona.

U ovom periodu ANEM je, zajedno sa partnerima iz Medijske koalicije, reagovao dva puta na sporni postupak javne nabavke usluga informisanja koji je Grad Niš u junu sproveo na način koji nije u interesu, ni lokalnih građana, ni lokalnih medija. THESE ARE THE MOST IMPORTANT ACTIVITIES OF THE ASSOCIATION IN THE LAST THREE MONTHS:

1. LEGAL MONITORING OF THE SERBIAN MEDIA SCENE

a) ANEM Monitoring Reports on the media scene in Serbia

In this period, ANEM released on its website three new Monitoring Reports in 2013: for **March – No. 42**; for **April – No. 43** and for **May – No. 44**, where you can read how the Serbian media scene looked like in those months. The report for **June – No. 45, will be released soon!**

b) Eighth ANEM Monitoring Publication

In June 2013, ANEM published electronic version of the **Eighth Monitoring Publication**, containing the texts of the authors: attorney at law Kruna Savovic – on media reform in Serbia; attorney at law Slobodan Kremenjak – on state aid; Ombudsman Sasa Jankovic – on freedom of expression; doc. Dr. Boban Tomic – on media literacy. The fifth text presents short overviews of two judgments of the European Court of Human Rights concerning freedom of expression. c) Monitoring Round Table VIII – presentation of the printed edition of the Eighth Monitoring Publication

On the occasion of the public presentation of the printed edition of the Eighth Monitoring Publication, on July 10, 2013, ANEM organized a round table in Belgrade, which was attended by a large number of stakeholders. Following the authors' presentations of their texts, a constructive discussion on the media situation in Serbia was opened. Read more about it in the report from the round table [here](#).

2. ANEM PARTICIPATION IN THE DRAFTING OF THE NEW ADVERTISING LAW

The competent Ministry of Foreign and Domestic Trade and Telecommunications formed a Working Group in April 2013, tasking it with developing an expert basis for the Draft Advertising Law. As one of the members of the Working Group, ANEM President Sasa Mirkovic delivered to the Ministry and other members of the Working Group, on May 15, 2013, written remarks and suggestions of ANEM on the Draft Advertising Law that is a basis for further work on the legislation. 3. FINAL COMMENTS ON THE DRAFT LAW ON PUBLIC INFORMATION AND MEDIA

After public discussion and consultation with state authorities and bodies, the competent Ministry of Culture and Media prepared the Draft Law on Public Information and Media and forwarded it to the Working Group for opinion. Sasa Mirkovic, ANEM President and representative of the Media Coalition in the Working Group, submitted to the Ministry the Coalition's remarks on the final version of the Draft Law together with concrete proposals for amending certain articles of the Draft. 4. ANEM PARTICIPATION IN PUBLIC DEBATE ON THE DRAFT LAW ON SPECIAL POWERS

By taking part in the public debate on the Draft Law on Special Powers for effective protection of intellectual property rights, on July 1, 2013, ANEM submitted to the Intellectual Property its written remarks and suggestions on the Draft Law, which you can read [here](#).

5. ANEM AT THE PUBLIC DISCUSSION BEFORE THE CONSTITUTIONAL COURT

On July 2, 2013, a public discussion was held before the Constitutional Court of the Republic of Serbia, for assessing the constitutionality of certain provisions of the Law on National Councils of National Minorities. The proceedings were initiated as a result of a number of initiatives submitted to the Court, including the one by ANEM. What did representatives of ANEM say at a public discussion, read [here](#).

6. ANEM ON PROPOSED SINGLE TARIFF OF OFPS AND PI

Responding to an invitation of the Intellectual Property Office, on July 8, 2013, ANEM delivered its opinion on the Proposal of a single tariff of OFPS and PI from May 20, 2013, which you can read [here](#).

7. ANEM ON DRAFT ACTION PLAN ACCOMPANYING THE ANTI-CORRUPTION STRATEGY

Considering fight against corruption a priority for the progress of society, ANEM took participation in the public discussion of this document, with its written comments submitted to the Ministry on July 12, 2013 and by participating in the discussion in Belgrade on July 15, 2013. 8. MEDIA COMMUNITY AT THE SESSION OF CULTURE AND INFORMATION COMMITTEE

Following ANEM monitoring round table held on July 10, 2013, where delayed media reforms in Serbia were discussed and which was attended by the Secretary of the Serbian Parliament's Culture and Information Committee, representatives of the Media Community were invited to attend the session of this Committee scheduled for July 17. 9. ACTIVITIES OF THE PROJECT "ILLUSTRATED GLOSSARY OF CORRUPTION"

a) Workshop for selected journalists-correspondents

The workshop, organized by ANEM for its most successful journalists who had been selected at the internal competition to participate in the production of the series "Illustrated Glossary of Corruption as journalists-correspondents", was held on May 16, 2013 in Belgrade. The aim of the workshop was to present the concept of programs of the series to journalists, as well as provide them with concrete explanations regarding their role and tasks in the production. b) Recording of the series "Illustrated Glossary of Corruption" started

The activity of production of the radio and TV series "Illustrated Glossary of Corruption" has begun as part of the activities foreseen by the project of the same title. Following the workshop held in May 2013, where selected local

journalists-correspondents were given specific tasks for investigative work in the field, recording of four local stories that would illustrate the same number of selected terms of corruption, was prepared during June. You can find more information [here](#).

10. ANEM STATEMENTS

In its statement on July 15, 2013, ANEM strongly protested over the articles published in the last two issues of the daily "Informer", which further threatened to the safety of Veran Matic and that of other journalists being under police protection currently or getting one soon.

In a joint statement of June 14, 2013, ANEM, together with its partners from the Media Coalition (NUNS, UNS, NDNV and Local Press), welcomed the decision of the Constitutional Court of the Republic of Serbia to have declared unconstitutional certain provisions of the Law on Electronic Communications with respect to access to withheld data, which were regarded as conflicting back when this law was in the process of adoption.

In this period, ANEM, together with its partners from the Media Coalition, reacted twice to the controversial procedure of public procurement of information services that the City of Nis conducted in June in a manner that was not in the interest of either local citizens, or local media. The Coalition released **the first statement** on June 3, 2013 and **the second** on June 19, 2013.
