### ***JULSKI MONITORING IZVEŠTAJ NA SAJTU ANEM-a!***

#### **KRATAK SADRŽAJ MONITORING IZVEŠTAJA br.46 za jul 2013:**

- **Sloboda izražavanja** – *pretnje i pritisci*: 4 slučaja koji se odnose na neprimerene pritiske na medije, koji su potencijalna opasnost po slobodu izražavanja, a od kojih dva čak potiču iz medijske sfere, a jedan od lidera opozicione stranke: pismo lidera Demokratske stranke i Gradonačelnika Beograda rukovodstvu RTS-a, kojim se ukazuje na navodnu neprofesionalnost i pristrasnost u informisanju građana Srbije u informativnom programu republičkog javnog servisa; kampanja koju vlasnik Televizije Pink Željko Mitrović već nedeljama vodi protiv dnevnog lista „Blic“, iznoseći pri tom negativne stavove o tom listu i o glavnom i odgovornom uredniku Veselinu Simonoviću; polemika u dnevnom listu „Informer“ o razlozima dodeljivanja obezbeđenja uredniku informativnog programa B92 Veranu Matiću; kao i napadi po nacionalnoj osnovi na predsednika Izvršnog odbora NDNV-a Nedima Sejdinovića, putem Internet portala „Koreni“; u delu *sudski postupci*: Presuda Apelacionog suda u Novom Sadu protiv Preduzeća za proizvodnju i distribuciju RTV programa „TV Apatin“ d.o.o. Apatin, koji je osnivač lista „Novi glas komune“ i Vesne Milanović Simčić, glavne i odgovorne urednice ovog lista, kojom su tuženi obavezani da tužiocima Nenadu Nišiću i Vesni Nišić isplate milionski iznos zbog povrede časti i ugleda u vezi sa člankom o samoubistvu njihove ćerke, koja, osim što je sporna po pravnom rezonu, značajno utiče i na sposobnost ovog medija da finansijski opstane, dok su pravni lekovi svedeni na Ustavnu žalbu i Posebnu reviziju, koji ne odlažu izvršenje.
- **Implementacija postojećih zakona** – *Zakon o radiodifuziji*: kako se primenjuju zakonske odredbe koje se odnose na Javni konkurs za izdavanje dozvola za emitovanje TV programa za nacionalno, regionalno i lokalno pokrivanje, uz poseban osvrt na javne razgovore koje je Savet RRA obavio sa predstavnicima podnosilaca prijave na javni konkurs za nacionalno pokrivanje – TV NOVA.rs i TV Kopernikus;
- **Usvajanje novih zakona** – kakav je plan nadležnog ministarstva u pogledu usvajanja medijskih zakona? Kako zastoj u medijskoj reformi vide Delegacija EK u Srbiji, ali i zvaničnici Direktorata EU za proširenje?
- **Rad nadležnih organa** – na koji je način RRA ocenila ispunjavanje programskih i zakonskih obaveza Javnog servisa Autonomne pokrajine Vojvodina? Šta nedostaje u ovoj analizi RRA i da li daje pravu sliku ispunjavanja programskih i zakonskih obaveza emitera? Kako je Savet za štampu odlučivao u postupcima protiv medija u vezi sa poštovanjem Kodeksa novinara Srbije?
- **Proces digitalizacije** – zašto je došlo do praktičnog zaustavljanja procesa digitalizacije?
- **Proces privatizacije medija** – nastavak privatizacije jednog lokalnog medija posle 3 godine zastoja;
- **Zaključak Izveštaja** – koje su to „anti-reformske tendencije“ u medijskoj sferi u julu mesecu?

## ***JULY MONITORING REPORT ON ANEM'S WEBSITE!***

### **SHORT SUMMARY OF THE JULY MONITORING REPORT no. 46 for July 2013:**

- **Freedom of expression** – *threats and pressures*: four cases of undue pressure on the media, of which two in the media sphere: the letter of the leader of the Democratic Party and Mayor of Belgrade to the RTS, protesting over the alleged lack of professionalism and impartiality; the campaign waged by the owner of TV Pink Zeljko Mitrovic against the daily Blic and its Editor-in-Chief Veselin Simonovic; the daily Informer's questioning the reasons for placing B92's Editor-in-Chief Veran Matic under police protection, as well as the ethnically motivated attacks against the President of the Executive Board of NDNV Nedim Sejdinovic on the web portal "Koreni". In the part about *Legal Proceedings*, the authors address the questionable verdict of the Appellate Court in Novi Sad against the Company for the Production and Distribution of TV Program "TV Apatin" d.o.o. from Apatin, which is the founder of the newspaper "Novi glas komune", and Vesna Milanovic Simcic, the Editor-in-Chief of the same, which verdict ordered the defendants to pay one million dinars in damages for injured honor and reputation, in relation to the suicide of their daughter. That decision is not only legally questionable, but also affects the financial survival of the said media outlet, with the only remedies being the constitutional appeal and special review, which do not delay the enforcement of the verdict.
- **Implementation of existing laws** – *the Broadcasting Law*: the implementation of the statutory provisions concerning the open competition for the issuance of broadcasting licenses with national, regional and local coverage, with a special emphasis on the discussions between the RBA Council and the representatives of the applicants on the open competition for national coverage – TV NOVA.rs and TV Kopernikus;
- **Adoption of new laws** – what is the plan of the ministry as to the adoption of media laws? What is the view of the EC Delegation to Serbia and GD Enlargement officials about the delay in the adoption of media laws?
- **Work of the competent authorities** – How has the RBA evaluated the fulfillment of programming and statutory obligations of the PBS in the Autonomous Province of Vojvodina? Where is RBA's analysis lacking and does it provide an accurate picture of the broadcasters' fulfillment of their obligations? What decisions did the Press Council make in proceedings against media for breaches of the Journalists' Code of Ethics?
- **The digitalization process** – Why was the digitalization process practically stopped?
- **Media privatization** – The continuation of privatization of a local media after three years of standstill;
- **Conclusion of the Report** – what were the "anti-reform tendencies" on the media landscape in the month of July?
