1. PRAVNI MONITORING MEDIJSKE SCENE U SRBIJI

2. POKRENUT POSTUPAK ZA OCENU USTAVNOSTI POJEDINIH ODREDBA ZAKONA O KINEMATOGRAFIJI

Ustavni sud je, na sednici održanoj 18. decembra 2013. godine, doneo rešenje o pokretanju postupka za ocenu ustavnosti odredaba člana 19. stav 1. tač. 3. i 4. Zakona o kinematografiji, koje se odnose na obezbeđivanje sredstava za razvoj kinematografije izdvajanjem dela sredstava koje RRA i RATEL, regulatorna tela u oblasti radiodifuzije, ostvaruju prikupljanjem naknada, shodno zakonima. ANEM je Inicijativu za ocenu ustavnosti tih odredaba podneo Ustavnom sudu u maju 2012. godine. 3. PREDLOZI ANEMA ZA IZRADU NOVE STRATEGIJE RADIODIFUZIJE

ANEM je 31.12.2013. dostavio RRA svoje predloge za izradu nove Strategije radiodifuzije u Republici Srbiji. Taj dokument, osim preporuka, sadrži i analizu domaćeg i evropskog regulatornog okvira za elektronske medije, kao i ocenu ostvarenosti Strategije radiodifuzije do 2013. godine, po oblastima koje je RRA Strategijom utvrdila kao osnovne ciljeve/pravce razvoja radiodifuzije u Srbiji. 4. KOMENTARI ANEMA NA IZMENA ZAKONA O ELEKTRONSKIM KOMUNIKACIJAMA

ANEM je 20. decembra 2013. dostavio nadležnom ministarstvu svoje pisane komentare na Nacrt zakona o izmenama i dopunama Zakona o elektronskim komunikacijama, u kojima je naveo opšte primedbe na Nacrt zakona, kao i posebne, sa predlogom konkretnih izmena i dopuna Nacrta. 5. UČEŠĆE ANEMA U JAVNOJ RASPRAVI O IZMENAMA ZAKONA O AUTORSKOM I SRODNIM PRAVIMA

Zakon o autorskom i srodnim pravima jedan je od važnih propisa koji čine regulatorni okvir za elektronske medije. Smatrajući da pojedine predložene izmene tog zakona nisu dobro formulisane, kao i da su neke važne izmene izostale, ANEM je 16. decembra 2013. dostavio Zavodu za intelektualnu svojinu svoje komentare na Nacrt zakona, u kojima je dao svoje primedbe i sugestije. 6. ODLUKA USTAVNOG SUDA U POSTUPKU PO INICIJATIVI ANEMA

Zakon o zaštiti prava i sloboda nacionalnih manjina sadržao je sporne odredbe kojima je državi bilo dato pravo da osniva radio i TV stanice koje bi emitovale program na jezicima nacionalnih manjina. U postupku po Inicijativi ANEM-a za ocenu ustavnosti tih odredaba, Ustavni sud je utvrdio da sporne odredbe nisu u saglasnosti sa Ustavom i iste su prestale da važe 6. novembra 2013. 7. KOMENTARI ANEMA NA NACRT ZAKONA O JAVNIM MEDIJSKIM SERVISIMA

9. ZAHTEV ANEMA RRA-U ZA PRISTUP INFORMACIJAMA OD JAVNOG ZNAČAJA

ANEM je 30.10.2013. godine dostavio Republičkoj radiodifuznoj agenciji Zahtev za pristup informacijama od javnog značaja, a u vezi sa Javnim konkursom za izdavanje dozvole za emitovanje televizijskog programa za područje Republike, koji je objavljen u dnevnom listu „Politika“ 25. oktobra 2013. godine. Koja pitanja je postavio ANEM, a koje odgovore je dala RRA, pogledajte [ovde](#).

10. SAOPŠTENJA ANEM-a

U saopštenju od 16. decembra 2013, ANEM je izrazio protest povodom napada na novinarske ekipe TV B92 i TV Prva, članice ANEM-a, tokom izveštavanja o incidentima na lokalnim izborima u Odžacima 15 decembra. ANEM je od nadležnih zahtevao da istraže sve okolnosti vezane za ovaj napad, a odgovorne izvedu pred lice pravde.

U saopštenju od 4. decembra 2013, ANEM je najoštrije protestovao povodom odluke Saveta Republičke radiodifuzne agencije (RRA) da izrekne mere opomene Javnom servisu Vojvodine zbog načina vođenja intervjua sa političarkom s Kosova Atifetom Jahjagom, tačnije zato što novinar sagovornici nije oponirao potpitanjima. Podjednako je nerazumljiva i odluka, smatra ANEM, da RRA izrekne opomenu članici ANEM-a Radiju B92 zbog emitovanja satiričnog priloga koji je sadržavao izjavu navodno uvredljivu za Predsednika Republike, pri čemu je ANEM napomenuo da je kontroverzna izjava analizirana van konteksta. ANEM je pozvao RRA da preispita ove sporne odluke kojima se nedopušteno meša u uređivačku politiku medija i ograničava slobodu izražavanja.

U saopštenju od 12. novembra 2013, ANEM je izrazio zabrinutost što se u pojedinim štampanim medijima pojavljuju najave početka rada Televizije Nova, koje dodatno komplikuju situaciju koja je nastala odlukom RRA da raspiše javni konkurs za nacionalno pokrivanje, koji ima brojne formalne i materijalne nedostatke, javnost dovode u zabludu oko prirode novog pružaoca medijske usluge i kreiraju atmosferu neprimerenog pritiska na odlučivanje nezavisnog regulatora. ANEM je podsetio da, prema informacijama kojima raspolaže, TV Nova nije dobila dozvolu za nacionalnu frekvenciju, niti je poznato da li joj je izdata privremena dozvola za emitovanje. Zato je ANEM u saopštenju zahtevao od RRA da odgovori na nekoliko pitanja u vezi sa ovim slučajem.

U saopštenju od 31. oktobra 2013, ANEM je izrazio protest povodom raspisivanja Javnog konkursa za dodeljivanje dozvole za emitovanje TV programa za teritoriju Republike Srbije, uprkos tome što nisu ispunjeni ni formalni ni materijalni uslovi koje predviđa Zakon o radiodifuziji. ANEM je zato zahtevao od RRA da odgovori na nekoliko pitanja o vezi sa tim konkursom i uputio je Agenciji zahtev za pristup informacijama od javnog značaja.

U saopštenju od 25. oktobra 2013, ANEM je objavio da je njegov Upravni odbor izabrao Milorada Tadića za novog predsednika ANEM-a. Na ovoj funkciji Tadić je zamenio Sašu Mirkovića koji je podneo ostavku zbog odlaska na mesto pomoćnika ministra kulture i informisanja zaduženog za medije. Tadić je direktor i glavni i odgovorni urednik Radija Boom 93 u Požarevcu, koji je pokrenuo 1992. Jedan je od osnivača i dugogodišnji potpredsednik ANEM-a, a bio je i koordinator Asocijacije od 1999 do 2001.

U saopštenju od 4. oktobra 2013, ANEM je pozdravio odluku Ustavnog suda Republike Srbije kojom su određene odredbe Zakona o zaštiti prava i sloboda nacionalnih manjina proglašene neustavnim, a prema kojima država može da osniva i posebne radio i televizijske stanice koje bi emitovale programe na jezicima nacionalnih manjina. ANEM je podsetio da bi slične odredbe iz ostalih zakona morale biti što pre uklonjene iz pravnog poretka budući da je za funkcionalno medijsko tržište neophodno kreirati ravnopravne uslove za sve njegove učesnike, što u postojećim okolnostima paralelnog funkcionisanja privatnih i neprivatizovanih medija sa nejednakim položajem, na štetu privatnih, nije moguće ostvariti.

U saopštenju od 9. avgusta 2013, ANEM je zahtevao da se upražnjene frekvencije TV Avala iskoriste za okončanje procesa digitalizacije budući da je ovaj proces jedan od prioriteta u kontekstu sprovođenja Medijske strategije i jedan od ključnih činilaca za uspešno sprovođenje medijske reforme. ANEM je apelovao na nadležne državne organe da u

najkraćem mogućem roku usvoje Plan raspodele koji će upražnjene frekvencije rezervisati za proširenje Inicijalne mreže za testiranje digitalnog TV signala.

11. PODRŠKA PROJEKTU „ILUSTROVANI REČNIK KORUPCIJE“

Kao vid podrške projektu „Ilustrovani rečnik korupcije“, ANEM je na svom web sajtu otvorio novu rubriku pod nazivom „Korupcija u fokusu“, koja treba da usmeri pažnju javnosti na problem korupcije i da omogući zainteresovanim stranama da na jednom mestu nađu relevantne tekstove koji se bave tom temom. Rubrika sadrži vesti koje se odnose na problem korupcije u Srbiji i inostranstvu, prvenstveno u regionu. Više o tome [ovde](#).

1. LEGAL MONITORING OF THE SERBIAN MEDIA SCENE

a) ANEM Monitoring Reports on the Serbian media scene

In six Monitoring Reports, which ANEM published on its website in this period, you can read expert legal analyses and assessments of all significant developments on the media scene in the following months: **July** – report **no. 46**; **August** – report **no. 47**, **September** – report **no. 48**, **October** – report **no. 49**, **November** – report **no. 50** and **December** – report **no. 51**.

b) Ninth ANEM Monitoring Publication

ANEM published its **Ninth Monitoring Publication** on its website in December 2013. The Publication contains the articles by following authors: attorney at law Slobodan Kremenjak – on the responsibility of the media for users'

comments on websites; attorney at law Miloš Stojković – do draft media laws foster media pluralism; judge Dragica Popesku, PhD – on some debatable issues in disputes between the authors of photographs and the media; journalist Tamara Skrozza – on ethics in the media. The fifth text presents short overviews of two judgments of the European Court of Human Rights concerning the application of the Article 10 of the European Convention for the Protection of Human Rights and Fundamental Freedoms. c) ANEM Monitoring Round Table IX

On December 23, 2013, ANEM organized a round table in Belgrade where it publicly presented the print edition of the Ninth Monitoring Publication. The event was attended by more than 50 participants. 2. PROCEDURE FOR ASSESSING THE CONSTITUTIONALITY OF CERTAIN PROVISIONS OF THE LAW ON CINEMATOGRAPHY INITIATED

At the session held on 18 December 2013, the Constitutional Court passed a ruling to initiate the procedure for assessing the constitutionality of the provisions of Article 19, Paragraph 1, points 3 and 4 of the Law on Cinematography. These provisions determine that the funds for the development of cinematography shall be provided, inter alia, by allocating part of the funds which RBA and RATEL, the regulatory bodies in the area of broadcasting, collect from fees, pursuant to the law. The Initiative for assessing the constitutionality of these provisions ANEM submitted to the Constitutional Court in May 2012. What ANEM stated in its Initiative and what the Court's ruling in its reasons contains, read [here](#).

3. ANEM SUGGESTIONS FOR NEW BROADCASTING STRATEGY

On December 31, 2013, ANEM submitted to RBA its Suggestions for the new Broadcasting Strategy in the Republic of Serbia. The document, apart from the suggestions, contains the analysis of the Serbian and the European regulatory framework for broadcast media and the assessment of the fulfilment of the Broadcasting Strategy until 2013, covering the areas which RBA in the Strategy established as fundamental goals/directions of broadcasting development in Serbia. 4. ANEM COMMENTS ON THE AMENDMENTS TO THE LAW ON ELECTRONIC COMMUNICATIONS

On December 20, 2013, ANEM submitted to the competent ministry its written comments to the Draft Law on the Amendments to the Law on Electronic Communications. In addition to general remarks on the Draft Law, ANEM has offered specific remarks with proposals for amending the provisions of the Draft. Please, read ANEM comments [here](#).

5. ANEM PARTICIPATION IN PUBLIC DEBATE ABOUT AMENDING THE LAW ON COPYRIGHT AND RELATED RIGHTS

The Law on Copyright and Related Rights is one of the important regulations the regulatory framework for broadcast media is consisted of. Bearing in mind that some of the suggested amendments to the Law are not well formulated, and that some important amendments are missing, ANEM submitted to the Intellectual Property Office its comments (remarks and suggestions) on the Draft Law on December 16, 2013. 6. DECISION OF THE CONSTITUTIONAL COURT IN THE PROCEEDINGS BASED ON ANEM INITIATIVE

The Law on the Protection of National Minorities' Rights and Freedoms contained disputable provisions that allowed the state to establish radio and TV stations which would broadcast programs in the languages of national minorities. In the procedure based on the ANEM Initiative for the assessment of constitutionality of these provisions, the Constitutional Court established that disputable provisions are not in conformity with the Constitution and they ceased to be valid on November 6, 2013. 7. ANEM COMMENTS ON THE DRAFT LAW ON PUBLIC SERVICE BROADCASTING

ANEM took part in the public debate on the Draft Law on Public Service Broadcasting. In its written comments of October 31, 2013, ANEM stated remarks and concrete suggestions for the improvement of certain provisions of the Draft Law. See ANEM remarks and suggestions [here](#).

8. ANEM COMMENTS ON THE DRAFT LAW ON ELECTRONIC MEDIA

The comments on the Draft Law on Electronic Media, which ANEM submitted to the competent ministry on October 31, 2013, during public debate, contained general remarks and concrete suggestions for the amendments to the Draft, as well as the reasons for the proposed amendments. 9. ANEM REQUEST TO RBA FOR ACCESS TO INFORMATION OF PUBLIC IMPORTANCE

On October 30, 2013, ANEM submitted to the RBA a request for access to information of public importance regarding the Public tender (open competition) for issuing TV broadcasting license for the territory of the Republic of Serbia, published in the daily "Politika" on October 25, 2013. 10. ANEM STATEMENTS

In its statement December 16, 2013, ANEM protested the attacks on the teams of journalists with TV B92 and TV Prva - members of ANEM - that took place while they were reporting on incidents that occurred during the local election held in Odzaci on December 15. ANEM demanded that the authorities investigate all circumstances of the attack on the television crews and prosecute the perpetrators.

In the statement on December 4, 2013, ANEM strongly protested the Council of the Republic Broadcasting Agency's (RBA) decision to issue a public warning to the Public Service Broadcaster of Vojvodina because of the manner in which an interview with a politician from Kosovo, Atifete Jahjaga, was conducted, namely because the journalist did not oppose the interviewee by asking her additional questions. ANEM also objected to the Council's decision to issue a public warning to Radio B92 for airing a satirical report with an allegedly insulting statement concerning the President of the Republic, stressing that RBA has analyzed the controversial statement completely out of context. ANEM called on the RBA to reconsider these controversial decisions which, according to ANEM, interfere with the editorial policy of the media and limit the freedom of expression.

In the statement on November 12, 2013, ANEM expressed its concern because certain print media outlets have published reports announcing impending launch of TV Nova, additionally complicating the already complex situation that has resulted from the decision by the Republic Broadcasting Agency (RBA) to hold a public contest for a broadcasting frequency with national coverage which suffers from numerous formal and technical flaws. At the same time, these reports have misled the public regarding the characteristics of the new broadcaster and created an atmosphere of inappropriate pressure on the deciding process of the independent regulator. ANEM reminded that, according to its information, TV Nova had not obtained licence for a national frequency, neither it is known whether it was issued a temporary broadcasting licence. Therefore, ANEM requested from RBA to answer a set of questions regarding the case in question.

In its statement on October 31, 2013, ANEM protested because Public tender for national TV license had been announced, although neither formal nor material conditions prescribed by the Law on Broadcasting have been met. Therefore, ANEM requested RBA to answer several question concerning the tender and filed to RBA a request for access to information of public importance.

In the statement on October 25, 2013, ANEM announced that its Managing Board had elected Milorad Tadic as the new president of ANEM. Tadic took over the position from Sasa Mirkovic who had resigned due to his appointment at the position of the Assistant to Minister of Culture and Media, responsible for media. Tadic is the general manager and chief editor of Radio Boom 93 in Pozarevac, which he launched in 1992. He is also one of the founders and long standing vice president of ANEM, and he was also ANEM coordinator from 1999 to 2001.

In the statement on October 4, 2013, ANEM welcomed the decision by the Constitutional Court of the Republic of Serbia which declared unconstitutional certain provisions of the Law on Protection of Rights and Freedom of National Minorities. According to the provisions, the state can establish radio and TV stations which would broadcast programs in the the languages of national minorities. ANEM reminded that all similar provisions from other laws should be removed as soon as possible considering that a functional media market requires equal conditions for all its participants, which is not possible in the current situation where private and non-privatized media operate simultaneously with the unequal position in the market to the detriment of the private media outlets.

In the statement on August 9, 2013, ANEM demanded that vacated frequencies of TV Avala be used to complete the process of digitalization as this process is one of the priorities in the context of the implementation of the Media Strategy and one of the key factors in successful realization of the media reform. ANEM called on the authorities to adopt the Allocation Plan as soon as possible which would allocate the vacated frequencies for the purpose of expansion of the Initial Network for Digital Television Signal Testing.

11. SUPPORT TO THE PROJECT "ILLUSTRATED GLOSSARY OF CORRUPTION"

As a support to the project "Illustrated Glossary of Corruption", ANEM launched a new section on its website, titled "Corruption in Focus". The section is intended to direct the attention of the public to the problem of corruption and to enable interested parties to find in one place relevant texts dealing with this topic. The section contains news about the problem of corruption in Serbia and abroad, primarily in the region. More about it [here](#).

12. CAMPAIGN FOR MEDIA LITERACY

In August 2013, Media coalition (NUNS, UNS, NDNV, Local press and ANEM) started a 15 months project titled “Campaign for Media Literacy”, aimed at strengthening and supporting democratization of the Serbian society through the promotion of media literacy and independent and accountable journalism.
